Pastor Ben's Report

- Motion to approve Mardi Gras Party for 2/23/22 by all council members via email 2/1/22, motion passed
- Door 1 is broken and requires replacement; \$14K bid from Midland Glass includes handicap feature
 - Council in support of replacement with handicap accessibility, but congregational vote is required given the cost exceeds \$10K
 - **o** Will open up to designated donations from congregation to help cover the cost (*Please refer to updated Door 1 information in the March 2022 minutes*)

Pastor Alicia's Report

- Motion to approve Endowment Funds for the following: by Hauck, Nybo second, motion passed
 - o \$1,000 for Changing Gaits: financial assistance for families with youth in need of life-affirming equine assisted therapy
 - o \$1,000 for Racial Justice Team to purchase books for Anti-Racist Little Free Library. There was a leak in the library and the books need to be replaced.
- Motion to approve changes to Worship beginning with Lent by all council members via email 2/16/22, motion passed
 - Ash Wednesday 3/2/22: Adding a noon service. Prepare individual cups for people to administer ashes on their family units or self. *In conversations with other churches, ash distribution using Q-tips is another common option we are considering.
 - Sunday Worship: Children's sermon in the front, Noisy offering during offering in church, Choir practices at 8 am during Lent
 - Wednesday Worship: Kids in worship but Crew Time breaks off before Gospel/sermon, Crew Time returns for noisy offering
