- Motion to commit \$25,000 to Synod Mission Support for 2024 by Nybo, second Gieseke, motion approved
- Motion to approve the following Mission Outreach recommendations by Gieseke, second Tietz, motion approved
  - Fixed dollar amount allocations
    - Liz Nelson: The final \$150 Little Food Pantry/Little Household Pantry for December 2023
    - Pastoral/Office Discretionary funds: \$1,015 remained as of the last CSSW report submitted to MO dated through 9/30/2023. If additional funds were issued between 9/30/2023 and today, the amount will be less than \$1,015.
    - Snow Removal for Peace Garden: \$1,000
  - Percentage of remaining tithe at 2023 year end, which are all organizations that they have supported in the past.
    - ELCA Disaster Relief Fund: 30%
    - National Alliance on Mental Illness Minnesota: 25%
    - River Valley Health Services: 25%

## **Revised NEXT Proposal**

- Teams in attendance: Capital campaign leadership, lead gifts, and NEXT facilities teams
- Laura Magnuson walked through progression of NEXT facilities project
- Given the capital campaign goal was not met, we have a revised scope option to consider, which is more aligned with the original project goals, and checks more boxes.
  - o Sanctuary
    - Rotate orientation, expand seating, raise ceiling, relocate nursery
  - o CYF Space
    - Refresh rooms and open up current game room
  - o Kitchen (current space)
    - Remove serving window, replace oven, add ice maker, create prep space
  - o Kitchen (new serving area)
    - Relocate office/storage and convert to serving area
  - o Grand entrance/lobby expansion will not be part of this scope but will be considered as a future project
  - o Revised cost: \$2.14M
