- Road Update On August 29, George Winn delivered the Road Extension Project Proposal, dated 6/26/2025, requesting the Church Council President's signature in order to be hand-delivered to the City of New Prague. Via email, the following motion was conducted.
  - Motion to approve the plans and Deutsch construction proposal to begin work by Bishop, seconded by Gieseke. Motion Approved.
  - George Winn provided a project update at the 9/16/2025 council meeting. The project should be completed in a few weeks, which includes tree and dirt removal, manhole for water runoff, a driveway, curb and street. The project also provides evidence to the city that the parking lot work has been initiated. Therefore, the city will allow for the parking lot to be completed under current code.
